Slight correction to a stat I gave: From the inception of CalRecycle's food recovery related grants in 2014, food waste prevention programs and food recovery organizations have prevented or recovered approximately 290M pounds of edible food that otherwise would have been landfilled. That is equivalent to approximately 242M meals served to food insecure individuals. Impressive, but still so much to do!
